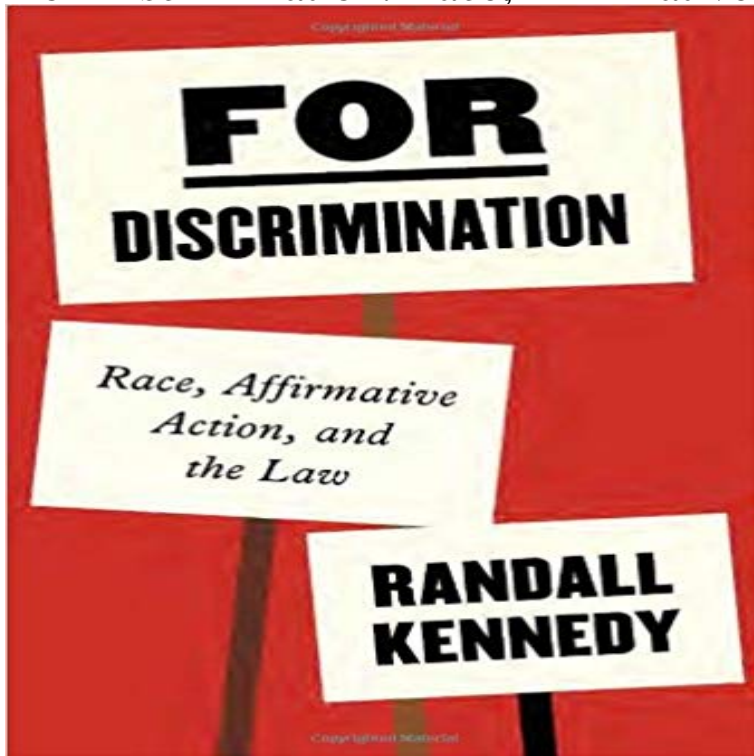


For Discrimination: Race, Affirmative Action, and the Law
