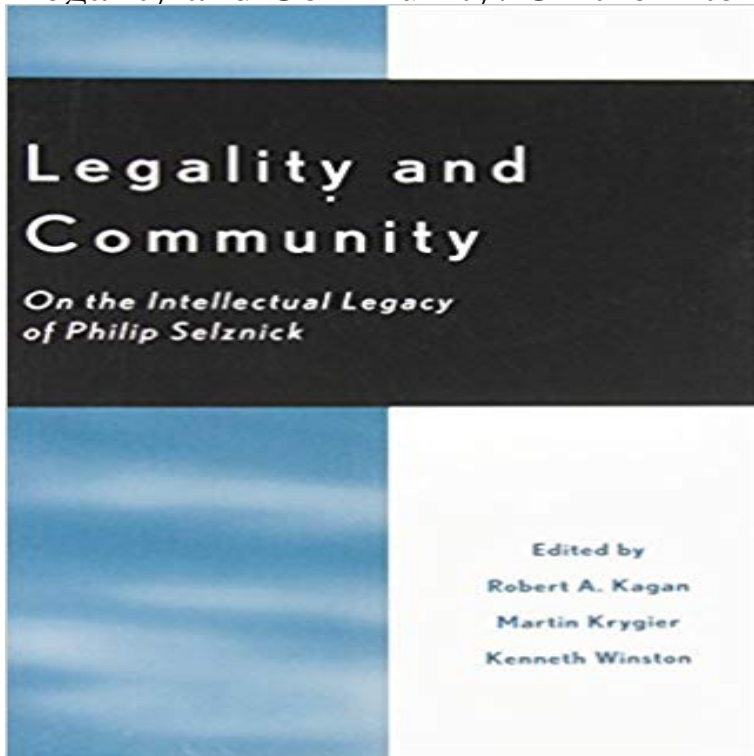


# Legality and Community: On the Intellectual Legacy of Philip Selznick
