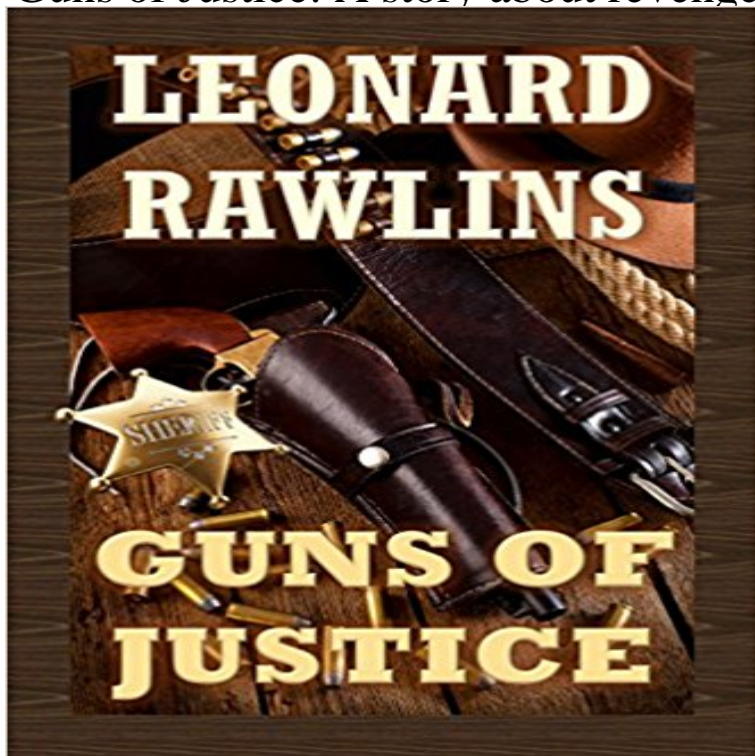


## Guns of Justice: A story about revenge in the wild west
